The Johnson County LEPC met on Tuesday, March 12, 2013 at the JECC. Chairman Dave Stannard called the meeting to order at 10:00 AM. Greetings were extended and self introductions were made. Also, a sign-in as passed.

- Old Business
  - The minutes from the October  $2^{nd}$ , 2012 meeting were approved.
- Update on COAD, EVC Training and preparedness strategies-(BJ)
  - The Community Organizations Active in Disaster (COAD) group has been meeting quarterly. The group has divided into four committees: Needs and Resource Assessment, Long Term Recovery Committee, Volunteer Management and Donations Management. The next meeting will be on May 28<sup>th</sup> at the JECC. The Emergency Volunteer Center currently has 128 volunteers trained. Their next training will be on April 23<sup>rd</sup>.
- IOWARN- (Kevin Slutts)
  - Kevin Slutts gave a presentation on the Iowa Water Waste Water Agency Response Network. IOWARN is the formalized system of "utilities helping utilities" to deliver mutual aid following major emergencies. Infrastructure will consist of a network of public and private utilities, a steering committee, a web-based communication system and a mutual aid agreement.
- ESF 10 plan review and Cameo updates/status reports. (BJ)
  - The ESF 10 Hazmat Plan was sent out to the group for review. Revisions were made to the plan and will be sent to the State for approval.
  - There are currently 18 people who will be attending the FFY 13 HMEP grant funded CAMEO class March 13<sup>th</sup>-15<sup>th</sup>.
  - For FFY 14, \$2,644.51 is the estimated amount of grant funding that the LEPC will be receiving through HMEP to send 4 people to Hazmat Tech School in Lansing, MI. We also submitted to have the mileage reimbursed and also to have a hazmat refresher class.
- Haz Mat Team report or areas of concern-(BJ)
  - On 12-10-12, the hazmat team responded to I-80/262 MM in Cedar County for a Semi that was leaking diesel fuel.
  - Recertification exams were completed in December by all hazmat team members.
  - The Lumex mercury monitor is currently back in service. It was sent to Ohio to be repaired and calibrated.
  - Added some new equipment to the Hazmat 1 truck.
  - Lettering and decals were put on the decon trailer. It also had some minor repairs made to it.

Johnson County will sound the outdoor warning sirens for 1 minute to indicate the start of the drill. There will not be an April siren test.
