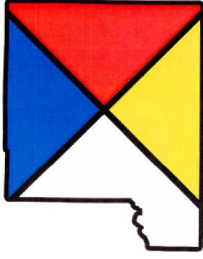
#### Old Business

  - Working on a HMEP grant Change of Scope as the training plan for ICFD has changed and we had submitted for in-house HAZMAT Tech Training.

  - Training
    1. Darren Pemberton (UHIC) – Internal discussion about increasing their HAZMAT capabilities.
